Chapter 1

Introduction

1.1. Preliminaries

Definition 1.1.1:[3] The set of all square integrable function is known as L^2 -space;

$$L^2(\mathbb{R}) = \left\{ f : \mathbb{R} \longrightarrow \mathbb{C} \mid \int_{\mathbb{R}} |f(x)|^2 dx < +\infty \right\}$$

Definition 1.1.2:[3] For $f \in L^2(\mathbb{R})$ and $\xi \in \mathbb{R}$,

$$\hat{f}(\xi) = \int_{\mathbb{R}} f(x)e^{-ix\xi} dx, \quad x \in \mathbb{R}$$

$\hat{f}(\xi)$ is known as the Fourier Transform of $f(x)$.

Definition 1.1.3:[3] For $g \in L^2(\mathbb{R})$ and $x \in \mathbb{R}$, \check{g} is defined as,

$$\check{g}(x) = \frac{1}{2\pi} \int_{\mathbb{R}} g(\xi)e^{ix\xi} d\xi,$$

$\check{g}(x)$ is called the inverse Fourier Transform of $g(x)$.

Definition 1.1.4:[3] Hardy Space $H^2(\mathbb{R})$ is the collection of all square integrable functions

whose Fourier transform is supported in $\mathbb{R}^+ = (0, \infty)$;

$$H^2(\mathbb{R}) = \{f \in L^2(\mathbb{R}) : \hat{f}(\xi) = 0 \text{ for a.e. } \xi \leq 0\}.$$

$H^2(\mathbb{R})$ is a closed subspace of $L^2(\mathbb{R})$.

1.2. Hardy Wavelet and Hardy MRA

Definition 1.2.1:[3] A function $\psi \in H^2(\mathbb{R})$ is said to be a Hardy wavelet, if the system of functions $\{\psi_{j,k} = 2^{j/2}\psi(2^j \cdot -k) : j, k \in \mathbb{Z}\}$ forms an orthonormal basis for $H^2(\mathbb{R})$.

Theorem 1.2.2:[3] A function $\psi \in H^2(\mathbb{R})$, with $\|\psi\|_2 = 1$, is an orthonormal wavelet for $H^2(\mathbb{R})$ if and only if

$$\sum_{j \in \mathbb{Z}} |\hat{\psi}(2^j \xi)|^2 = \chi_{\mathbb{R}^+}(\xi) \text{ for a.e. } \xi \in \mathbb{R}$$

$$\sum_{j=0}^{\infty} \hat{\psi}(2^j \xi) \overline{\hat{\psi}(2^j(\xi + 2k\pi))} = 0 \text{ for a.e. } \xi \in \mathbb{R}, k \in 2\mathbb{Z} + 1$$

Similar to MRA for wavelets in $L^2(\mathbb{R})$ MRA for Hardy wavelets are also defined called H^2 -MRA.

Definition 1.2.3:[3] A sequence $\{V_j : j \in \mathbb{Z}\}$ of closed subspaces of $H^2(\mathbb{R})$ is a multiresolution analysis for $H^2(\mathbb{R})$ if the following properties are satisfied:

1. $V_j \subset V_{j+1}$ for all $j \in \mathbb{Z}$;
2. $f \in V_j$ if and only if $f(2(\cdot)) \in V_{j+1}$ for all $j \in \mathbb{Z}$;
3. $\bigcap_{j \in \mathbb{Z}} V_j = \{0\}$;
4. $\overline{\bigcup_{j \in \mathbb{Z}} V_j} = H^2(\mathbb{R})$;
5. There exists a $\varphi \in V_0$, such that $\{\varphi(\cdot - k) : k \in \mathbb{Z}\}$ is an orthonormal basis for V_0 .

The function φ is called a **scaling function** of the given MRA.

Associated with each H^2 -MRA there is a Hardy wavelet. The construction of Hardy wavelet from an H^2 -MRA follows on the same lines as that of an orthonormal wavelet in $L^2(\mathbb{R})$, given in [3].

From the definition of MRA, $V_0 \subset V_1$. Let $V_1 = V_0 \oplus W_0$, where W_0 is the orthogonal complement of V_0 in V_1 . Now the elements of W_0 can be dilated by 2^j to obtain a closed subspace W_j of V_{j+1} such that

$$V_{j+1} = V_j \oplus W_j \quad \text{for each } j \in \mathbb{Z}.$$

From property (4) of MRA,

$$H^2(\mathbb{R}) = \bigoplus_{j=-\infty}^{\infty} W_j.$$

We have to find a $\psi \in W_0$ such that $\{2^{j/2}\psi(2^j \cdot -k) : k \in \mathbb{Z}\}$ is an orthonormal basis for W_j , for all $j \in \mathbb{Z}$. Then $\{\psi_{j,k} : j, k \in \mathbb{Z}\}$ will form an orthonormal basis for $H^2(\mathbb{R})$. Since $\varphi \in V_0 \subset V_1$, therefore $\{\sqrt{2}\varphi(2 \cdot -k) : k \in \mathbb{Z}\}$ is an orthonormal basis for V_1 , and hence

$$\varphi(\xi) = \sum_{k \in \mathbb{Z}} a_k \sqrt{2}\varphi(2\xi - k)$$

where the coefficients a_k are given by $a_k = \langle \varphi(\xi), \sqrt{2}\varphi(2\xi - k) \rangle$.

$$\hat{\phi}(2\xi) = m_0(\xi)\hat{\phi}(\xi)$$

for a.e. $\xi \in \mathbb{R}$, where m_0 is a 2π -periodic function called the low-pass filter associated with the scaling function φ .

The filter $m_0(\xi)$ associated with φ satisfies

$$|m_0(\xi)|^2 + |m_0(\xi + \pi)|^2 = 1$$

for a.e. $\xi \in \mathbb{R}$.

$\psi \in H^2(\mathbb{R})$ is an orthonormal wavelet associated with the given MRA iff

$$\hat{\psi}(2\xi) = e^{i\xi} \nu(2\xi) \overline{m_0(\xi + \pi)} \hat{\varphi}(\xi)$$

a.e. on \mathbb{R} , for some 2π -periodic measurable function ν such that

$$|\nu(\xi)| = 1 \quad \text{a.e. on } \mathbb{T}.$$

Relation between $|\hat{\varphi}|$ and $|\hat{\psi}|$ [3]

From previous results we obtain

$$\begin{aligned} |\hat{\varphi}(2\xi)|^2 + |\hat{\psi}(2\xi)|^2 &= |\hat{\varphi}(\xi)|^2 |m_0(\xi)|^2 + |\hat{\varphi}(\xi)|^2 |m_0(\xi + \pi)|^2 \\ &= |\hat{\varphi}(\xi)|^2 (|m_0(\xi)|^2 + |m_0(\xi + \pi)|^2) \\ &= |\hat{\varphi}(\xi)|^2 \end{aligned}$$

By repeating this result and applying the Fatou's lemma, we obtain

$$|\hat{\varphi}(\xi)|^2 = \sum_{j=1}^{\infty} |\hat{\psi}(2^j \xi)|^2 \quad \text{for a.e. } \xi \in \mathbb{R}.$$

Proposition 1.2.4:[3] *If ψ is an H^2 -wavelet associated with an H^2 -MRA, then*

$$D_\psi(\xi) = \sum_{j=1}^{\infty} \sum_{k \in \mathbb{Z}} |\hat{\psi}(2^j(\xi + 2k\pi))|^2 = 1 \quad \text{for a.e. } \xi \in \mathbb{R}.$$

Proof. From the relation given above it follows that

$$\begin{aligned} |\hat{\varphi}(\xi)|^2 &= \sum_{j=1}^{\infty} |\hat{\psi}(2^j \xi)|^2 \text{ for a.e. } \xi \in \mathbb{R} \\ \Rightarrow \sum_{k \in \mathbb{Z}} |\hat{\varphi}(\xi + 2k\pi)|^2 &= \sum_{k \in \mathbb{Z}} \sum_{j=1}^{\infty} |\hat{\psi}(2^j(\xi + 2k\pi))|^2 \\ \Rightarrow 1 &= \sum_{j=1}^{\infty} \sum_{k \in \mathbb{Z}} |\hat{\psi}(2^j(\xi + 2k\pi))|^2 \\ \Rightarrow D_{\psi}(\xi) &= 1 \text{ for a.e. } \xi \in \mathbb{R}. \end{aligned}$$

Chapter 2

Hardy wavelet induced isomorphism

2.1. Hardy wavelet Set

Definition 2.1.1:[3] Hardy wavelet set is a measurable subset E of \mathbb{R} such that the inverse Fourier transform of χ_E is an orthonormal wavelet in $H^2(\mathbb{R})$.

In [2] all the one and two interval Hardy wavelet sets were characterized. $[2\pi, 4\pi]$ is the only one interval Hardy wavelet set and the two-interval Hardy wavelet sets are given by

$$\left[\frac{2(k+1)}{2^{j+1}-1}\pi, \frac{2k}{2^j-1}\pi \right] \cup \left[\frac{2^{j+1}k}{2^j-1}\pi, \frac{2^{j+2}(k+1)}{2^{j+1}-1}\pi \right]$$

with $j > 0$ and $0 < k < 2(2^j - 1)$.

The following result gives a characterization of H^2 wavelet sets.

Proposition 2.1.2:[1] *Let $K \in \mathbb{R}^+$ be a measurable set. Then K is a Hardy wavelet set if and only if the following two conditions hold:*

(i) $\{K + 2k\pi : k \in \mathbb{Z}\}$ is a partition of \mathbb{R} .

(ii) $\{2^j K : k \in \mathbb{Z}\}$ is a partition of \mathbb{R}^+ .

2.2. Hardy wavelet induced isomorphism

Ionascu in his paper [4] defined wavelet induced isomorphisms for wavelet sets in $L^2(\mathbb{R})$.

By using the similar idea we defined Hardy wavelet induced isomorphisms (HWII) for

Hardy wavelet sets. In [4] the set E was taken as $[-2\pi, -\pi) \cup [\pi, 2\pi)$, but since the dilates of Hardy wavelet sets partition only the positive real axis therefore for Hardy wavelet sets we used $E = [2\pi, 4\pi)$. The translation map τ is same and the dilation map has domain \mathbb{R}^+ instead of \mathbb{R} .

The translation map $\tau : \mathbb{R} \longrightarrow E$ is given by $\tau(x) = x + 2\pi j$, where j is a unique integer satisfying $x + 2\pi j \in E$. Similarly the dilation map $\delta : \mathbb{R}^+ \longrightarrow E$ is defined by $\delta(x) = 2^k x$, where k is a unique integer satisfying $2^k x \in E$.

Let W be a Hardy wavelet set, then the map h_W from E to E is defined by $h_W = \tau|_W \circ (\delta|_W)^{-1}$. Further, similar to [4], the Hardy wavelet induced isomorphism (HWII) is $\tilde{h}_W = \xi \circ h_W \circ \xi^{-1} : [0, 1) \longrightarrow [0, 1)$, where $\xi : E \longrightarrow [0, 1)$ is defined as

$$\xi(x) = \frac{x}{2\pi} - 1, \quad x \in E,$$

and

$$\xi^{-1}(x) = 2\pi(x + 1), \quad x \in [0, 1).$$

Theorem 2.2.1: *Let W be a Hardy wavelet set and \tilde{h}_W be defined as above. Then the map \tilde{h}_W has the following properties:*

- (i) \tilde{h}_W is a measurable bijection of $[0, 1)$,
- (ii) For each $x \in [0, 1)$,

$$\tilde{h}_W = \lfloor 2^l(x + 1) \rfloor,$$

where $l \in \mathbb{Z}$ and $\lfloor x \rfloor$ denotes the fractional part of the real number x .

(iii) if h is a map satisfying (i) and (ii) then there exists a wavelet set W such $h = \tilde{h}_W$.

Proof: (i) By definition it follows that $\tau|_W, \delta|_W : W \rightarrow E$ are measurable bijections.

Hence $(\delta|_W)^{-1}$ is also a measurable bijection. We can easily see that ξ and ξ^{-1} are measurable bijections and therefore \tilde{h}_W is a measurable bijection of $[0, 1)$.

(ii) Now, $\tau(t) = \xi^{-1}(\lfloor \frac{t}{2\pi} \rfloor)$, for every $t \in \mathbb{R}$. For if, $\lfloor \frac{t}{2\pi} \rfloor = n + d$, where n =integral part and d =fractional part, then $\xi^{-1}(\lfloor \frac{t}{2\pi} \rfloor) = 2\pi \lfloor \frac{t}{2\pi} \rfloor + 2\pi = 2\pi(n + d) + 2\pi = 2\pi(n + d + 1)$. Further,

$$\begin{aligned}
\tau(t) &= \tau(2n\pi + 2d\pi) \\
&= (2n\pi + 2d\pi) + 2m\pi, \quad m \in \mathbb{Z} \\
&= 2\pi d + 2\pi(n + m) \\
&= 2\pi(d + n + m) \in [2\pi, 4\pi) \\
&\Rightarrow 1 \leq d + n + m \leq 2 \\
&\Rightarrow n + m = 1 \\
&\Rightarrow \tau(t) = 2\pi(d + 1)
\end{aligned}$$

Thus, $\tau(t) = \xi^{-1}(\lfloor \frac{t}{2\pi} \rfloor)$. Let $u = \xi^{-1}(x) = 2\pi(x + 1)$ and $\delta^{-1}(u) = 2^l u$ with $l \in \mathbb{Z}$. Then we have $\tau(2^l u) = \xi^{-1}(\lfloor \frac{2^l u}{2\pi} \rfloor) = \xi^{-1}(\lfloor 2^l(x + 1) \rfloor)$. We know that $h_W(x) = \tau|_W \circ (\delta|_W)^{-1}(x) = \tau(2^l x)$. Now

$$\begin{aligned}
\tilde{h}_W(x) &= \xi \circ h_W \circ \xi^{-1}(x) \\
&= \xi \circ h_W(2\pi(x+1)) \\
&= \xi(\tau(2^l(x+1)2\pi)) \\
&= \xi(\tau(2^l u)) \\
&= \xi\xi^{-1}[\lfloor 2^l(x+1) \rfloor] \\
&= \lfloor 2^l(x+1) \rfloor \\
\Rightarrow \tilde{h}_W(x) &= \lfloor 2^l(x+1) \rfloor
\end{aligned}$$

(iii) Next suppose that h has the properties (i) and (ii), and denote $h_1 = \xi^{-1} \circ h \circ \xi : E \rightarrow E$.

$$\begin{aligned}
h_1(x) &= \xi^{-1} \circ h \circ \xi(x) \\
&= \xi^{-1} \circ h\left(\frac{x}{2\pi} - 1\right) \\
&= \xi^{-1}(\lfloor 2^k\left(\frac{x}{2\pi} - 1 + 1\right) \rfloor) \\
&= \xi^{-1}(\lfloor \frac{2^k x}{2\pi} \rfloor) \\
&= 2^k x + 2l\pi \\
&= 2^{k(x)}x + 2l(x)\pi, k(x), l(x) \in \mathbb{Z}
\end{aligned}$$

The map $x \rightarrow k(x)$ and $x \rightarrow l(x)$ are measurable. Let $\psi : E \rightarrow \mathbb{R}$ be defined by $\psi(x) = 2^{k(x)}x, x \in E$, and $W = \psi(E)$. Then W is measurable. ψ is bijective as it is both onto and one to one. If we take any point from W then we can find a pre-image in E .

Now let $x_1 \neq x_2$ be two points in E and $\psi(x_1) = 2^{k_1}x_1, \psi(x_2) = 2^{k_2}x_2$. We want to

prove that $2^{k_1}x_1 \neq 2^{k_2}x_2$. On the contrary suppose that $2^{k_1}x_1 = 2^{k_2}x_2$.

$k_1 = k_2 = k \Rightarrow 2^k(x_1 - x_2) = 0 \Rightarrow x_1 = x_2$. Therefore k_1 can not be equal to k_2 .

Further if, $k_1 > k_2$, then $2^{k_1}x_1 = 2^{k_2}x_2$ implies that $2^{k_1-k_2}x_1 = x_2$. Since $x_1, x_2 \in E$, therefore even for $k_1 - k_2 = 1$, $\Rightarrow 2^{k_1-k_2}x_1 \neq x_2 \Rightarrow \psi(x_1) \neq \psi(x_2)$. Hence ψ is one-one.

Since $\delta|_W(W) = E$, therefore $(\delta|_W)^{-1}(E) = W$ and $\psi(E) = W$ implies that $\psi = (\delta|_W)^{-1}$.

Next we define $\varphi : W \rightarrow E$ by $\varphi(y) = y + 2l(\psi^{-1}(y))\pi$.

$$\begin{aligned}
\varphi \circ \psi(x) &= \varphi(\psi(x)) \\
&= \varphi(2^{k(x)}x) \\
&= 2^{k(x)}x + 2l(2^{-k(x)}2^{k(x)}x)\pi \\
&= 2^{k(x)}x + 2l(x)\pi \\
&= h_1(x) \\
\Rightarrow \varphi \circ \psi &= h_1
\end{aligned}$$

Now as defined above $\varphi(W) = E$. Since $\tau|_W(W) = E$, therefore $\varphi(y) = \tau|_W(y)$, for $y \in W$.

This proves that ψ is onto and h_1 is one to one, hence φ is one to one. Since h_1 is onto, therefore φ is also onto. Thus W is a wavelet set. The map $h_1 = \varphi \circ \psi = \tau|_W \circ (\delta|_W)^{-1} = h_W$ and $h = \xi \circ h \circ \xi^{-1} = \tilde{h}_W$.

Chapter 3

Fixed point sets of Hardy wavelet induced isomorphism

3.1. Examples of HWII

Consider the two interval Hardy wavelet sets W given by

$$W = \left[\frac{2(k+1)}{2^{j+1}-1}\pi, \frac{2k}{2^j-1}\pi \right) \cup \left[\frac{2^{j+1}k}{2^j-1}\pi, \frac{2^{j+2}(k+1)}{2^{j+1}-1}\pi \right)$$

with $j > 0$ and $0 < k < 2(2^j - 1)$.

Let us take the first case, $j = 1, k = 1$

$$W = \left[\frac{4}{3}\pi, 2\pi \right] \cup \left[4\pi, \frac{16}{3}\pi \right]$$

Then $\tau|_W, \delta|_W : W \rightarrow E$ are

$$\tau|_W(x) = \begin{cases} x + 2\pi & x \in [\frac{4}{3}\pi, 2\pi) \\ x - 2\pi & x \in [4\pi, \frac{16}{3}\pi) \end{cases}$$

and

$$\delta|_W(x) = \begin{cases} 2x & x \in [\frac{4}{3}\pi, 2\pi) \\ 2^{-1}x & x \in [4\pi, \frac{16}{3}\pi) \end{cases}$$

$$(\delta|_W)^{-1} : E \longrightarrow W$$

$$(\delta|_W)^{-1}(x) = \begin{cases} 2x & x \in [2\pi, \frac{8}{3}\pi) \\ 2^{-1}x & x \in [\frac{8}{3}\pi, 4\pi) \end{cases}$$

Now $h_W = \tau|_W \circ (\delta|_W)^{-1} : E \longrightarrow E$

$$h_W(x) = \begin{cases} 2x - 2\pi & x \in [2\pi, \frac{8}{3}\pi) \\ 2^{-1}x + 2\pi & x \in [\frac{8}{3}\pi, 4\pi) \end{cases}$$

Again $\tilde{h}_W = \xi \circ h_W \circ \xi^{-1} : [0, 1) \longrightarrow [0, 1)$. Here

$$\tilde{h}_W(x) = \begin{cases} [2(x+1)] & x \in [0, \frac{1}{3}) \\ [2^{-1}(x+1)] & x \in [\frac{1}{3}, 1) \end{cases}$$

Similarly we can obtain \tilde{h}_W for $j = 2$:

$$j = 2, k = 1$$

$$\tilde{h}_W(x) = \begin{cases} [2(x+1)] & x \in [0, \frac{1}{7}) \\ [2^{-2}(x+1)] & x \in [\frac{1}{7}, \frac{1}{3}) \\ [2^0(x+1)] & x \in [\frac{1}{3}, 1) \end{cases}$$

$$j = 2, k = 2$$

$$\tilde{h}_W(x) = \begin{cases} \lfloor 2^{-1}(x+1) \rfloor & x \in [0, \frac{1}{3}) \\ \lfloor 2(x+1) \rfloor & x \in [\frac{1}{3}, \frac{1}{2}) \\ \lfloor 2(x+1) \rfloor & x \in [\frac{1}{2}, \frac{5}{7}) \\ \lfloor 2^{-2}(x+1) \rfloor & x \in [\frac{5}{7}, 1) \end{cases}$$

$$j = 2, k = 3$$

$$\tilde{h}_W(x) = \begin{cases} \lfloor 2^2(x+1) \rfloor & x \in [0, \frac{1}{7}) \\ \lfloor 2^2(x+1) \rfloor & x \in [\frac{1}{7}, 1) \end{cases}$$

$$j = 2, k = 4$$

$$\tilde{h}_W(x) = \begin{cases} \lfloor 2^0(x+1) \rfloor & x \in [0, \frac{1}{3}) \\ \lfloor 2^2(x+1) \rfloor & x \in [\frac{1}{3}, \frac{3}{7}) \\ \lfloor 2^{-1}(x+1) \rfloor & x \in [\frac{3}{7}, 1) \end{cases}$$

$$j = 2, k = 5$$

$$\tilde{h}_W(x) = \begin{cases} \lfloor 2^0(x+1) \rfloor & x \in [0, \frac{2}{3}) \\ \lfloor 2^2(x+1) \rfloor & x \in [\frac{2}{3}, \frac{5}{7}) \\ \lfloor 2^{-1}(x+1) \rfloor & x \in [\frac{5}{7}, 1) \end{cases}$$

3.2. Fixed point sets of HWII

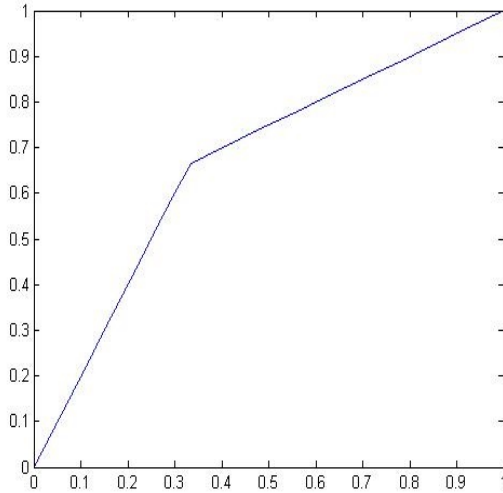
Theorem 3.2.1: *For the two-interval Hardy wavelet sets, whenever $k > 2^j - 1$, the corresponding wavelet induced isomorphism \tilde{h}_W possess fixed point sets of non-zero measure.*

Proof: For the proof note that if $k > 2^j - 1$, then $\frac{k}{2^j - 1} > 1$, or $\frac{2\pi k}{2^j - 1} > 2\pi$.

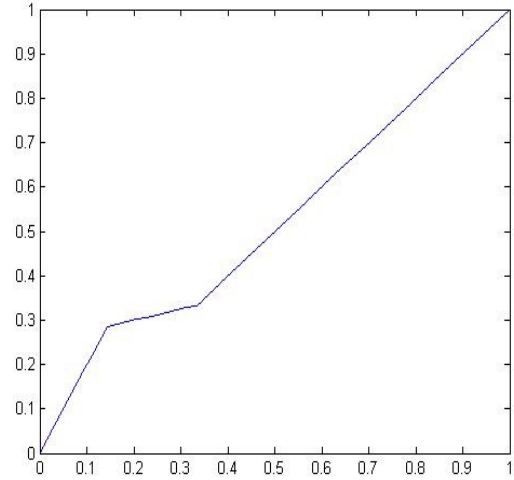
Also $k < 2(2^j - 1) = 2^{j+1} - 2$ implies that $\frac{2\pi(k+1)}{2^{j+1} - 1} < 2\pi$. Further $\frac{2\pi k}{2^j - 1} < 4\pi$. Thus the point 2π always lies in the first of the two intervals and

$$\left[2\pi, \frac{2k\pi}{2^j - 1}\right) \subseteq [2\pi, 4\pi).$$

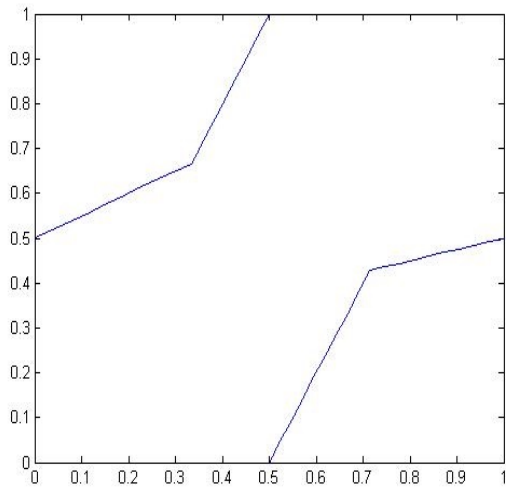
Thus both the translation and inverse dilation maps τ, δ^{-1} are identity maps on the subinterval $[2\pi, \frac{2k}{2^j - 1}\pi)$ of the two interval Hardy wavelet set and hence \tilde{h}_W is also an identity map on this subinterval. This proves that \tilde{h}_W has fixed point set of non-zero measure.



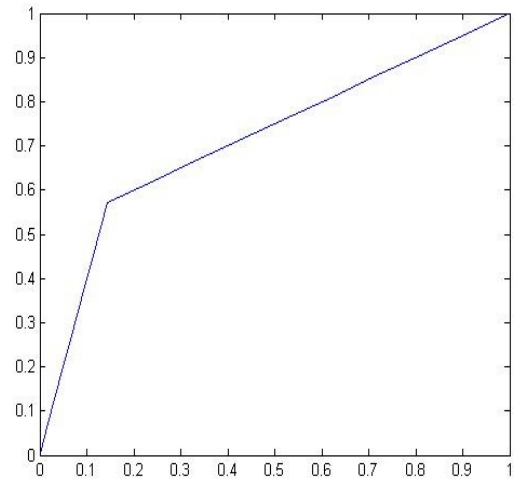
For j=1, k=1



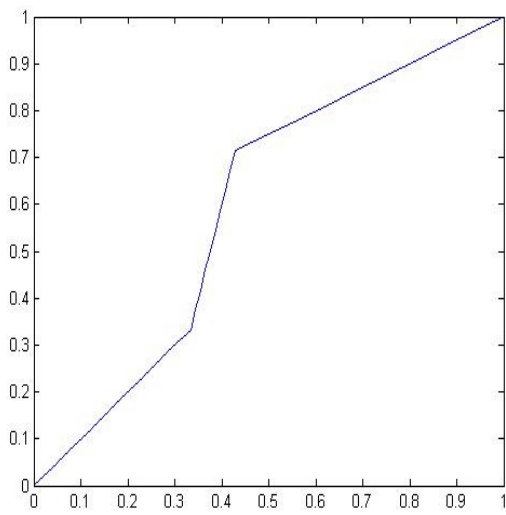
For j=2, k=1



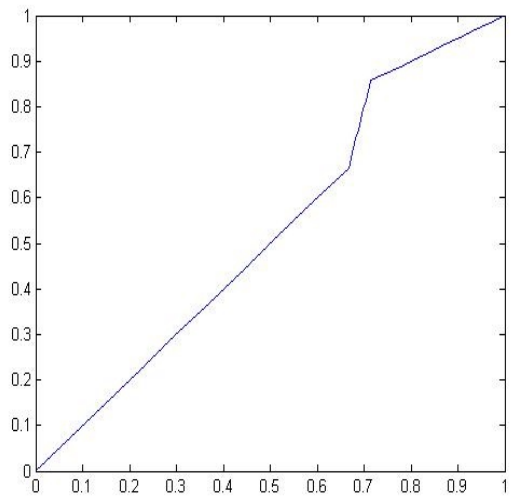
For $j=2, k=2$
